**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act relative to Diabetes prevention.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 111 of the General Laws is hereby amended by adding after section  
2 234 the following new section:—

3 Section 235. (a) The commissioner of public health shall establish within the department  
4 a diabetes action plan. The department shall develop the plan in consultation with the health  
5 policy commission, the center for health information and analysis, the group insurance  
6 commission and the division of medical assistance.

7 (b) The plan shall identify goals and benchmarks to reduce the prevalence and impact of  
8 diabetes in the commonwealth and develop appropriate state agency and department plans to  
9 reduce the incidence of diabetes in the commonwealth, improve diabetes care, and control  
10 complications associated with diabetes.

11 (c) The department , in consultation with department of public health, the health policy  
12 commission, the center for health information and analysis, the group insurance commission, and  
13 division of medical assistance, shall submit a report to the senate committee on ways and means,

14 the house committee on ways and means, the joint committee on health care financing, and the  
15 joint committee on public health, by July 1st of each odd-numbered year on (i) the financial  
16 effect of diabetes in the commonwealth and its political subdivisions; (ii) the number of persons  
17 affected by diabetes in the commonwealth; (iii) the number of persons included in prevention  
18 and diabetes control programs implemented by the department and other state agencies,  
19 municipalities, non-governmental entities and others; (iv) the effects and benefits of  
20 implemented programs and activities aimed at controlling diabetes and preventing the disease;  
21 (v) a description of the level of coordination existing between state agencies with respect to  
22 diabetes prevention, control and treatment and actions taken under the plan; (vi) a description of  
23 goals and benchmarks established pursuant to the plan; (vii) the extent of progress made toward  
24 achieving the goals and benchmarks established pursuant to the plan; (viii) a description of any  
25 additional actions that should be implemented relative to diabetes prevention, control and  
26 treatment; (ix) a description of the funding needs for any programs established or recommended  
27 pursuant to the plan; and (x) recommendations, if any, for legislation relative to diabetes  
28 prevention, control and treatment.
