## The Commonwealth of Massachusetts

In the One Hundred and Ninetieth General Court (2017-2018)

An Act granting equal access to original birth certificates to all persons born in Massachusetts.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:* 

1	SECTION 1. Section 2B of chapter 46 of the General Laws, as appearing in the
2	2014 Official Edition, is hereby amended by striking out, in lines 3 and 4, the words "on or
3	before July 17, 1974 or on or after January 1, 2008".
4	SECTION 2. Said section 2B of chapter 46, as so appearing, is hereby further amended
5	by striking out, in line 6, the words "on or after January 1, 2008".
