**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act improving treatment for Alzheimer's and Dementia.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 2 of chapter 112 of the General Laws, as appearing in the 2014 Official Edition,
2 is hereby amended by adding the following paragraph:-

3 The board shall require that any continuing education necessary for the renewal of a
4 physician’s certificate of registration shall include a course of training and education on the
5 diagnosis, treatment, and care of patients with cognitive impairments, including, but not limited
6 to, Alzheimer’s disease and dementia.
