An Act relative to Chapter 30B.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1 of chapter 30B of the General Laws is hereby amended by  
2 striking out, in lines 10 and 11, and in lines 138 and 139, as appearing in the 2014 Official  
3 Edition, the words “thirty-eight A1/2 to thirty-eight O, inclusive, of chapter seven” and inserting  
4 in place thereof, in each instance, the following words:- 44 to 57, inclusive, of chapter 7C.

5           SECTION 2. Subsection (b) of said section 1 of said chapter 30B is hereby amended by  
6 striking out clause (5), as so appearing, and inserting in place thereof the following clause:-

7           (5) a contract for the purchase of materials under specifications of the division of  
8 highways in the Massachusetts Department of Transportation and at prices established by the  
9 division, pursuant to advertising and bidding for such purpose, in connection with work to be  
10 performed under chapter 81 or chapter 90;

11 SECTION 3. Said section 1 of said chapter 30B is hereby further amended by striking  
12 out, in line 113, as so appearing, the words “subclause (r)” and inserting in place thereof the  
13 following words:- subclause (s).

14 SECTION 4. Section 5 of said chapter 30B is hereby amended by striking out, in lines  
15 62 to 64, inclusive, as so appearing, the words “the provisions of section eleven A 1/2 of chapter  
16 thirty A, section nine G of chapter thirty-four or section twenty-three B of chapter thirty-nine”  
17 and inserting in place thereof the following words:- sections 18 to 25, inclusive, of chapter 30A.

18 SECTION 5. Section 16 of said chapter 30B, as so appearing, is hereby amended by  
19 striking out, in line 46, the words “forty J of chapter seven” and inserting in place thereof the  
20 following words:- 38 of chapter 7C.

21 SECTION 6. Section 17 of said chapter 30B, as so appearing, is hereby amended by  
22 striking out, in line 12, the words “two thousand dollars” and inserting in place thereof the  
23 following figure:- \$10,000.

24 SECTION 7. Section 18 of said chapter 30B, as so appearing, is hereby amended by  
25 striking out the definition of “Disadvantaged vendor” and inserting in place thereof the following  
26 definition:-

27 “Disadvantaged vendor”, a business beneficially owned by at least 1 minority person as  
28 provided in the definition of “Minority-owned business” in subsection (b) of section 6 of chapter  
29 7C and any business beneficially owned by at least 1 woman as provided in the definition of  
30 “Women-owned business” in said subsection (b) of said section 6 of said chapter 7C.

31 SECTION 8. Section 23 of said chapter 30B is hereby repealed.
