## The Commonwealth of Massachusetts

In the One Hundred and Ninetieth General Court (2017-2018)

An Act An act relative to the disclosure of participation in the slave trade in the Commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

#### 1 SECTION 1. Chapter 7 of the General Laws is hereby amended by inserting after section

- 3 Section 63. (a) For the purposes of this section, the following words shall, unless the

4 context indicates otherwise, have the following meanings:

5 "Company" means any firm, corporation, partnership or combination of these which

6 employ over one hundred persons.

- 7 "Contract" means any agreement, franchise, lease or concession including an agreement
- 8 for any occasional professional or technical personal services, the performance of any work or
- 9 service, the provision of any materials or supplies or rendering of any service to any state agency

10 or state authority of the public, which is let, awarded, or entered into with or on behalf of any11 state agency or state authority.

12	"Enslaved Person" means any person who was wholly subject to the will of another and
13	whose person and services were wholly under the control of another and who was in a state of
14	enforced compulsory service to another during the Slavery Era.
15	"Investment" means to make use of an Enslaved Person for future benefits or advantages.
16	"License" means permission granted by a person to another to exercise a certain privilege
17	or to carry on a particular business.
18	"Majority-owned subsidiary" means a company that is at least fifty-one percent owned by
19	another company.
20	"Person" means any individual and any partnership, firm, association, corporation, or
21	other entity, or their subsidiaries.
22	"Participation" means having been a Slaveholder during the Slavery Era.
23	"Predecessor Company" means an entity whose ownership, title and interest, including
24	all rights, benefits, duties, and liabilities were acquired in an uninterrupted chain of succession
25	by the company.
26	"Profits" means any economic advantage or financial benefit derived from the use of
27	Enslaved Persons.
28	"Secretary" means the Secretary of Administration and Finance.
29	"Slavery" means the practice of owning Enslaved Persons.

"Slavery Era" means the period of time in North America and South America, including
the United States of America, Brazil, and the Caribbean, prior to1889.
"Slaveholder" means holders of Enslaved Persons, owners of business enterprises using
Enslaved Persons, owners of vessels carrying Enslaved Persons or other means of transporting
Enslaved Persons, merchants or financiers dealing in the purchase, sale or financing of the
business of Enslaved Persons.
"Slaveholder Insurance Policies" means policies issued to or for the benefit of
Slaveholders to insure them against the death of, or injury to, Enslaved Persons.
"State agency", all awarding authorities of the commonwealth, including, but not limited
to, all executive offices, agencies, departments, commissions, and public institutions of higher
education, and any office, department or division of the judiciary.

The company has searched any and all records of the company or majority-owned 62 subsidiary and any predecessor company or its majority-owned subsidiary regarding records of 63 participation or investments in, and profits derived, from slavery; and 64 B. The company has disclosed any and all records of participation in or profits 65 derived by the company or majority-owned subsidiary and any predecessor company or its 66 majority-owned subsidiary from slavery, including but not limited to, issuance of slaveholder 67 insurance policies provided by insurance companies, during the slavery era, and identified names 68 of any enslaved persons or slaveholders described in the records. 69 C. Subsections (A) and (B) of section 3 apply only to companies, majority-owned 70 subsidiaries, predecessor companies, and predecessor majority-owned subsidiaries in existence 71 before 1889.
