Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

by excluding a health care provider licensed under the laws of this state, irrespective of corporate structure or number of locations at which it conducts business, from participating on the carrier's or ACO's 's network of health care providers if the provider is located within the geographic coverage area of the health benefit plan and is willing to meet the terms and conditions of participation as established by the carrier or ACO as long as such measures are imposed equally

- (b) When a carrier or ACO denies a health care provider the right to enter into an
 agreement with the carrier or ACO on the grounds that the health care provider does not satisfy
 the terms and conditions established by the carrier or ACO for health care providers entering into
