An Act relative to purchasing marijuana.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 5I of chapter 18 of the General Laws, as appearing in the 2014  
2 Official Edition, is hereby amended by inserting, in line 34, after the words “chapter 138;” the  
3 following:- “marijuana as defined in section 1 of Chapter 94G;”

4           SECTION 2. Section 5J of chapter 18 of the General Laws, as appearing in the 2014  
5 Official Edition, is hereby amended by inserting in line 3, after the words “liquor stores” the  
6 following:- “marijuana establishments;”
