**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act regarding parental notification and consent.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 71 of the General Laws, as appearing in the 2014 Official Edition, is hereby
2 amended by inserting after Sections 37H and before Section 37H1/2 thereof the following new
3 section:—

4 Section 37H1/4.

5 (a) A teacher may send a student to the principal’s office to maintain effective discipline
6 in the classroom. The principal shall respond by employing appropriate discipline management
7 techniques consistent with the student code of conduct adopted under Section 37H, which shall
8 include conditions that authorize or require a principal or other appropriate administrator to
9 transfer a student to an alternative education program as provided by subsection (d). A teacher
10 may remove from class a student who has been documented by the teacher to repeatedly interfere
11 with the teacher’s ability to communicate effectively with the students in the class or with the
12 ability of the student’s classmates to learn; or whose behavior the teachers determines is so

13 unruly, disruptive, or abusive that it seriously interferes with the teacher's ability to
14 communicate effectively with the students in the class or with the ability of the student's
15 classmates to learn. If a teacher removes a student from class the principal may place the student
16 into in-school suspension or into an alternative education program. The terms of the removal
17 may prohibit the student from attending or participating in school-sponsored or school-related
18 activity. The principal may not return the student to that teacher's class without the teacher's
19 consent unless the committee established under subsection (b) determines that such placement is
20 the best or only alternative available.

21 (b) Each school shall establish a three-member committee to determine placement of a
22 student when a teacher refuses the return of a student to the teacher's class and make
23 recommendations to the district regarding re-admission of expelled students. Members shall be
24 appointed as follows: (1) the campus faculty shall choose two teachers to serve as members and
25 one teacher to serve as an alternate member; and, (2) the principal shall choose one member from
26 the professional staff of a campus. The teacher refusing to re-admit the student may not serve on
27 the committee.

28 (c) A student shall be removed from class and placed in an alternative education program
29 if the student engages in conduct that contains the elements of the offense of retaliation against
30 any school employee.

31 The terms of a placement under this section must prohibit the student from attending or
32 participating in a school-sponsored or school related activity.

33 (d) Each school district shall provide an alternative education program that is provided in
34 a setting other than a student's regular classroom; is located on or off of a regular school campus;

35 provides for the students who are assigned to the alternative education program to be separated
36 from students who are not assigned to the program; focuses on English language arts,
37 mathematics, science, history, and self-discipline; provides for students' educational and
38 behavioral needs; provides supervision and counseling; and, has as a program goal zero tolerance
39 for school violence. An alternative education program may provide for a student's transfer to: a
40 different campus, a school-community guidance center or a community-based alternative school.
41 A school district may provide an alternative education program jointly with one or more other
42 districts. Each school district shall cooperate with government agencies and community
43 organizations that provide services in the district to students placed in an alternative education
44 program. A student removed to an alternative education program is counted in computing the
45 average daily attendance of students in the district for the student's time in actual attendance in
46 the program.

47 A school district may not place a student in an unsupervised setting as a result of conduct
48 for which a student may be placed in an alternative education program.

49 (e) On request of a school district, the department of education shall provide to the
50 district information on developing an alternative education program that takes into consideration
51 the district's size, wealth, and existing facilities in determining the program best suited to the
52 district. The board of education shall establish an alternative education grant program to make
53 grant awards to school districts that have received approval for their alternative education plans.
54 A school district shall allocate to an alternative education program the same expenditure per
55 student attending the alternative education program, including federal, state, and local funds, that
56 would be allocated to the student's school if the student were attending the student's regularly
57 assigned education program, including a special education program.

58 (f) If a student placed in an alternative education program enrolls in another school
59 district before the expiration of the period of placement the superintendent of the district
60 requiring the placement shall provide to the district in which the student enrolls, at the same time
61 other records of the student are provided, a copy of the placement order. The district in which the
62 student enrolls may continue the alternative education program placement under the terms of the
63 order or may allow the student to attend regular classes without completing the period of
64 placement.

65 (g) A program of educational and support services may be provided to a student and the
66 student's parents when an offense involves drugs or alcohol.
