The Commonwealth of Alassachusetts

In the One Hundred and Ninetieth General Court (2017-2018)

An Act requiring state agencies to collect Asian American aggregate data.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Notwithstanding any General Law or Special Law to the contrary, all state
- 2 agencies, quasi-state agencies, entities created by state statute and sub-divisions of state agencies
- 3 shall identify Asian American and Pacific Islanders as defined by the United States Census
- 4 Bureau in all data collected as part any and all types of data collection, reporting or verification;
- 5 provided further that, the five largest Asian American and Pacific Islander ethnic groups residing
- 6 in the Commonwealth shall have individually reported data as part of the total Asian American
- 7 Pacific Islander reporting.
