An Act authorizing the town of Lincoln to exchange certain landfill property for conservation land.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding the provisions of any general or special law to the  
2 contrary and pursuant to the provisions of article 97 of the amendments to the Constitution of the  
3 Commonwealth of Massachusetts, the town of Lincoln board of selectmen, is hereby authorized  
4 to transfer a parcel of land, currently held for active and passive recreation and open space  
5 purposes, located at the corner of Route 2A (North Great Road) and Mill Street, and shown as  
6 Assessors Map 115, Lot 19, the portion to be transferred being a parcel of land containing  
7 309,850 square feet, more or less, approximately 7.1 acres, as shown on a plan captioned "Plan  
8 of Land in Lincoln, Massachusetts", dated 15, 1995, and recorded as Plan No. 380 of 1995 at the  
9 Middlesex South Registry of Deeds, and more particularly described in Appendix A to the "Vote  
10 of the Board of Selectman Taken at a Meeting on May 1, 1995", to the board of selectmen for

11 general municipal purposes, including, without limitation, for active and passive recreation and  
12 closed landfill purposes, and also for the purpose of leasing said land for solar energy purposes.

13 SECTION 2. In consideration for the transfer of the land as provided in section 1 of this  
14 act, the town of Lincoln board of selectmen shall acquire and/or dedicate for conservation  
15 purposes under the provisions of G.L. c.40, §8C, the property located at 100 Bedford Road,  
16 consisting of approximately 12.6 acres, more or less, which parcels are identified on the Lincoln  
17 Assessors' Maps as a portion of Parcel 127-11-0 (approximately 3.5 acres), a portion of Parcel  
18 127-10-0 (approximately .70 acres), Parcel 127-9-0 (approximately 1.4 acres), Parcel 127-7-0  
19 (approximately 2.8 acres), Parcel 127-6-0 (approximately .58 acres), and Parcel 127-19-0  
20 (approximately 3.7 acres), excluding from the above land a portion (approximately 3 acres)  
21 which will be held by the board of selectmen for recreational purposes, including, without  
22 limitation, for the development of an athletic field, which parcels, except for the approximately 3  
23 acres to be held for recreational/athletic field purposes, shall be subject and dedicated to the  
24 provisions of article 97 of the amendments to the Constitution of the Commonwealth of  
25 Massachusetts.

26 SECTION 3. This act shall take effect upon passage.
