By Mr. Murray of Milford, a petition (accompanied by bill, House, No. 3762) of Brian Murray and Ryan C. Fattman (by vote of the town) that the town of Milford be authorized to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises. Consumer Protection and Professional Licensure. [Local Approval Received.]

**The Commonwealth of Massachusetts**

**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act establishing an additional license for the sale of all alcoholic beverages to be drunk on premises.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding Section 17, of chapter 138 of the General Laws, the  
2   licensing authority for the Town of Milford may grant one (1) additional license for the sale of  
3   all alcoholic beverages to be drunk on the premises under section 12 of said Chapter 138, to Dee  
4   Zee, Inc.35 Anne Lane Pascoag, Rhode Island, d/b/a Trattoria, GiGi, for use in connection with  
5   premises situated at 198 East Main Street, in said Town of Milford. Said license shall be subject  
6   to all of the other provisions of said Chapter 138.

7           Notwithstanding any general or special law or any rule or regulation to the contrary, the  
8   licensing authority shall not approve the transfer of the license to any other location. The license  
9   may be re-issued by the licensing authority at the same location if an applicant for the license  
10   files with the licensing authority a letter in writing from the department of revenue indicating

11 that the license is in good standing with the department and that all applicable taxes have been  
12 paid.

13 If the license granted under this section is cancelled, revoked or no longer in use, it shall  
14 be returned physically, with all of the legal rights, privileges and restrictions pertaining thereto,  
15 to the licensing authority. Notwithstanding said section 17 of said chapter 138 or any other  
16 general or special law to the contrary, the licensing authority may then grant the license to a new  
17 applicant at the same location and under the same conditions as specified in the preceding  
18 paragraph.

19 SECTION 2. This act shall take effect upon passage.
