By Representative McMurtry of Dedham and Senator Rush, a joint petition (accompanied by bill, House, No. 4161) of Paul McMurtry and Michael F. Rush (by vote of the town) that the town of Dedham be authorized to convert a license for the sale of wine and malt beverages not to be drunk on the premises to a license for the sale of all alcoholic beverages not to be drunk on the premises in said town. Consumer Protection and Professional Licensure. [Local Approval Received.]

**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act authorizing the town of Dedham to convert a license for the sale of wine and malt beverages not to be drunk on the premises to a license for the sale of all alcoholic beverages not to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. (a) Notwithstanding sections 15 and 17 of chapter 138 of the General laws
2 or any other general or special law to the contrary, the license for the sale of wine and malt
3 beverages not to be drunk on the premises issued by the licensing authority for the town of
4 Dedham to R&Z Greige, Inc., for the premises at 77 Cedar street/7 Sanderson avenue, is
5 converted to a license for the sale of all alcoholic beverages not to be drunk on the premises,
6 subject to the conditions set forth in this act.

7 (b) The aforesaid license shall not be transferrable by R&Z Greige, Inc., for a period of
8 10 years from the date said license is so converted.

9 (c) The aforesaid license may only be utilized in connection with the operation of a food
10 store. For purposes of this act, a “food store” shall mean a grocery store, supermarket, variety
11 store, specialty store, or similar operation which sells at retail food for consumption off the
12 premises either alone or in combination with grocery items or other nondurable items typically
13 found in such stores for family, personal, or household use; provided, however, that such food
14 store shall carry fresh and processed meats, poultry, dairy products, eggs, fresh fruit and produce,
15 baked goods and baking ingredients, canned goods and dessert items; and provided, further, that
16 not more than 20 per cent of the gross floor area of such store shall be devoted to the open
17 display of alcoholic beverages for sale.

18 (d) Notwithstanding any provision to the contrary, all alcoholic beverages except wine
19 and malt beverages sold under said license shall be in bottles or other containers of greater than
20 16 ounces.

21 (e) Said license shall continue to be considered a wine and malt beverage license under
22 section 15 of the chapter 138 of the General Laws solely for the purposes of determining the
23 number of such wine and malt beverages licenses that may be granted by the town of Dedham
24 under the provisions of section 17 of chapter 138 of the General Laws.

25 SECTION 2. This act shall take effect upon its passage.
