**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act authorizing the town of Dedham to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding section 17 of chapter 138 of the General Laws, the local  
2   licensing authority of the town of Dedham may grant one additional license for the sale of all  
3   alcoholic beverages to be drunk on the premises, pursuant to section 12 of said chapter 138, to  
4   unnamed establishment owned by 900 Providence Highway Realty Trust # 2, located at 930  
5   Providence Highway in the town of Dedham, Massachusetts. The license shall be subject to all  
6   of said chapter 138 except said section 17.

7           (a)    The licensing authority shall not approve the transfer of the license to any other  
8   location, but it may grant the license to a new applicant at the same location if the applicant files  
9   with the licensing authority a letter from the department of revenue and a letter from the  
10   department of unemployment assistance indicating that the license is in good standing with those  
11   entities and that all applicable taxes, fees, and contributions have been paid.

12          (b)    If the license granted under this section is cancelled, revoked or no longer in use  
13   at the location of original issuance, it shall be returned physically, with all of the legal rights,

14 privileges and restrictions pertaining thereto, to the licensing authority which may then grant the  
15 license to a new applicant at the same location under the same conditions as specified in this act.

16 (c) All licenses granted pursuant to this act shall be issued within 12 months upon its  
17 passage.

18 SECTION 2. Notwithstanding section 12 and 77 of chapter 138 of the General Laws, the  
19 licensing authority for the town of Dedham may restrict the license issued pursuant to this act to  
20 holders of common vitualer licenses.

21 SECTION 3. This act shall take effect upon its passage.
