In the One Hundred and Ninetieth General Court (2017-2018)

An Act establishing a special commission to study the feasibility of a senior center building authority.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. There shall be a special commission (hereinafter "the Commission") to

study and evaluate current laws, regulations and practices related to building, funding, and

maintaining community senior centers and to make recommendations to improve the quality,

effectiveness and efficiency of state and local programs that enable the construction and

renovation of senior centers. Included in its overall mission, the Commission shall study the

7 SECTION 2. The Commission shall consist of 9 members: the Senate Chair of the Joint

Committee on Elder Affairs or a designee; who shall serve as Co-Chair of the Commission; the

House Chair of the Joint Committee on Elder Affairs or a designee, who shall serve as Co-Chair

of the Commission; the ranking Senate Republican of the Joint Committee on Elder Affairs or a

designee; the ranking House Republican of the Joint Committee on Elder Affairs or a designee;

the Secretary of Elder Affairs or a designee; the Secretary of Administration and Finance or a

designee; the Executive Director of the Massachusetts Councils on Aging, or a designee; two private citizens over the age of 65, appointed by the Governor in consultation with the leadership of the Massachusetts Councils on Aging.

SECTION 3. The Commission shall study and evaluate the current system for funding, approving, and building senior centers in Massachusetts communities. The Commission shall study the feasibility of establishing a Senior Center Building Authority (the "Authority") within the Executive Office of Elder Affairs that will administer grants and funds used to build senior centers, and may focus on the following issues: the structure and decision-making process of the Authority, operating rules and regulations of the Authority and any funding decisions made by said Authority, the independence and oversight of the Authority, and possible additional legislation required to facilitate senior center construction across the Commonwealth.

SECTION 4. The Commission shall convene the first official meeting on or before February 1, 2019. The Commission shall file a report of the study with recommendations for legislation not later than February 1, 2020 with the Clerks of the House of Representatives and Senate who shall forward the same to the House and Senate Committees on Ways and Means and the Joint Committee on Elder Affairs.
