**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act relative to the use of shotguns.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 66 of chapter 131 of the General Laws, as appearing in the 2012
2 Official Edition, is hereby amended by striking the section in its entirety and replacing it with the
3 following:-

4 "Section 66. The director, under the control of the board, may promulgate regulations for
5 the use and possession of shotgun ammunition types for the purposes of hunting."
