1           *Ordered,* That the committee on State Administration and Regulatory Oversight be  
2 authorized to sit during a recess of the General Court to make an investigation and study of  
3 Senate documents numbered 1686, 1704 and 1729 and House documents numbered 1666, 1689,  
4 1690, 1718, 2672, 3377 and 3814, relative to state administration.

5           Said committee shall report to the General Court the results of its investigation and study  
6 and its recommendations, if any, together with drafts of legislation necessary to carry such  
7 recommendations into effect, by filing the same with the Clerk of the House of Representatives  
8 on or before December 31, 2018.
