An Act changing the name of the board of selectmen of the town of North Reading.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1-3-1 of chapter 1 of the charter of the town of North Reading,
2 which is on file in the office of the archivist of the commonwealth, as provided in section 12 of
3 chapter 43B of the General Laws, is hereby amended by striking out the word "Selectmen" and
4 inserting in place thereof the following words:- select board.

5 SECTION 2. Section 2-4-8 of chapter 2 of said charter is hereby amended by striking out
6 the words "Board of Selectmen" and inserting in place thereof the following words:- select
7 board.

8 SECTION 3. Section 2-4-9 of chapter 2 of said charter is hereby amended by striking out
9 the words "Board of Selectmen" and inserting in place thereof the following words:- select
10 board.

11 SECTION 4. Section 3-1-1 of chapter 3 of said charter is hereby amended by striking out
12 the words "Board of Selectmen" and inserting in place thereof the following words:- select
13 board.

14 SECTION 5. Section 3-1-4 of chapter 3 of said charter is hereby amended by striking out
15 the words "Board of Selectmen" and inserting in place thereof the following words:- select

20 3-2-1 A select board of five members shall be elected for 3 year overlapping terms. The
21 regular election for the office of select board member shall be held in accordance with chapter 6
22 of this charter. Except as otherwise provided in this charter, the select board shall have all the
23 powers and duties of a board of selectmen pursuant to the General Laws.

79 chapter 185 of the acts of 1996, is hereby amended by striking out, in line 13, the word
80 "selectmen" and inserting in place thereof the following words:- select board.

81 SECTION 26. Section 6-3-4 of said chapter 6 of said charter, as so appearing, is hereby
82 amended by striking out, in lines 27, 28 and 33, the word "selectmen" each time it appears, and
83 inserting in place thereof, in each instance, the following words:- select board.

84 SECTION 27. Section 7-2-2 of chapter 7 of said charter, which is on file in the office of
85 the archivist of the commonwealth, as provided in section 12 of chapter 43B of the General
86 Laws, is hereby amended by striking out the words "Board of Selectmen" and inserting in place
87 thereof the following words:- select board.

88 SECTION 28. Section 7-3-1 of said chapter 7 of said charter is hereby amended by
