By Mr. Straus of Mattapoisett, a petition (accompanied by bill, House, No. 471) of William M. Straus and others for an investigation by a special commission (including members of the General Court) to study dredging needs for recreational boating in Commonwealth waterways. Environment, Natural Resources and Agriculture.

The Commonwealth of Massachusetts

**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act establishing a commission to study dredging needs for recreational boating in Commonwealth waterways.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. (a) There shall be established, under the Executive Office of Energy and
2 Environmental Affairs, a commission to research and review dredging needs for recreational
3 boating in Commonwealth waterways. Within one year, the Commission shall report to the
4 legislature on recommendations for how to: (i) fund such dredging projects; (ii) streamline the
5 permitting process for such dredging projects; (iii) reduce the costs associated with permitting
6 such projects; and (iv) identify disposal options, all for the purpose of maintaining and, where
7 appropriate, improving recreational boating access to the Commonwealth’s waterways. Special
8 attention shall be given to Commonwealth owned sediments requiring dredging to maintain
9 recreational boating access, irrespective of what entity owns or operates the boating facilities
10 associated therewith.

11 (b) (1) The commission shall have 9 members: 1 member to be appointed by the
12 governor, 1 member to be appointed by the secretary of energy and environmental affairs; 1
13 member to be appointed by the president of the senate for a term of 2 years; 1 member to be
14 appointed by the speaker of the house of representatives for a term of 2 years; 1 member to be
15 appointed by the senate minority leader, for a term of 2 year; and 1 member to be appointed by
16 the minority leader of the house of representatives; the Secretary of Energy and Environmental
17 Affairs, ex-officio and the Secretary of Housing and Economic Development, ex-officio. Each
18 member of the commission shall be an expert with experience in at least one of the following
19 fields: the business of recreational boating; environmental policy, public policy, economic
20 development or ocean management. At least one member shall be a director of a statewide non-
21 profit organization dedicated to the business of recreational boating. One of the members shall be
22 appointed by the governor to serve as chairperson of the commission. The Executive Office of
23 Energy and Environmental Affairs shall provide meeting space and administrative support to the
24 commission.

25 (2) The members of the commission shall receive no compensation for their services,
26 other than as may be already provided for due to their position outside the commission. The
27 commission may receive such funds to carry out its mission as may be authorized and
28 appropriated or donated from time to time.

29 (3) The powers of the commission shall be advisory.

30 (4) The commission may request from all state agencies such information and assistance
31 as the commission may require, which shall be provided as promptly as is reasonably practicable.
32 The commission may also request such information from companies and organizations with state

33 contracts that provide services relative to the scope of the commission, which shall also be
34 provided as promptly as is reasonably practicable.

35 (5) The commission shall convene its first meeting within one month of appointment
36 and shall submit its first report of recommendations not later than one year from appointment
37 with the clerks of the house of representatives and the senate who shall forward a copy of the
38 report to the house and senate chairs of the Joint Committee on Environment, Natural Resources
39 and Agriculture and the Governor.
