An Act relative to the providing of mammograms.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

2 Official Edition, is hereby amended, in line 21, by striking out the word “women” and inserting
3 in place thereof the word “patients”.

7 Section 3: Section 110 of Chapter 175 of the General Laws, as appearing in the 2012
