**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act relative to the endowment match program.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 15E of chapter 15A of the General Laws, as appearing in the official acts of
2 2014, is amended by removing the following words in the second paragraph “subject to
3 appropriation” and inserting the following after the last paragraph:

4 Not less than \$10,000,000 shall be appropriated in the current fiscal year to support this
5 program and subject to appropriation in subsequent years.
