**In the One Hundred and Ninetieth General Court  
(2017-2018)**

An Act providing for safe, decent and sanitary housing for recipients of the HomeBASE program.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Item 7004-9316 of section 2 of chapter 133 of the acts of 2016 is hereby amended by  
2 adding the following words:- ; provided, that for the safety of families utilizing HomeBASE  
3 funds provided for in this item for rental housing, an apartment or dwelling unit shall pass  
4 Department of Housing and Community Development inspection requirements or meet United  
5 States Department of Housing and Urban Development housing quality standards prior to  
6 occupancy and shall be inspected annually if any state funds are utilized for rental upon the  
7 anniversary of the commencement of the rental agreement; and provided, further that the local  
8 vendor for the HomeBASE funds where the dwelling is located and funds utilized shall be  
9 responsible for facilitating the inspection.
