**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act relative to noise reduction devices.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 10A of Chapter 269 of the Massachusetts General Laws is hereby amended by
2 deleting the section in its entirety and inserting in its place the following:

3 Section 10A.

4 Any person found to be in possession of a firearm suppressor who is:

- 5 (a) a prohibited person under section 131 of chapter 140;
- 6 (b) in the commission of a violent crime or felony;
- 7 (c) in the commission of a crime of violence against a family member;
- 8 (d) conducting sales or has possession of controlled substances as defined in chapter
9 94C;

11 shall be punished by imprisonment for not more than ten years in state prison or for not
12 more than two and one-half years in a jail or house of correction.

13 The term “firearm suppressor” or “firearm noise reduction device” means any device for
14 muffling or diminishing the report of a portable firearm, including any combination of parts,
15 designed or redesigned, and intended for use in assembling or fabricating a firearm muffler, and
16 any part intended only for use in such assembly or fabrication. For the purposes of this section
17 the term “firearm suppressor” or “firearm noise reduction device” shall have the same meaning
18 as Federal Law 18 USC 921(24).
