**In the One Hundred and Ninetieth General Court
(2017-2018)**

An Act relative to assault and battery on the elderly or disabled.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 13K of chapter 265 of the General Laws, as appearing in the 2012
2 Official Edition, is hereby amended by striking out, in line 72, the figure “3” and inserting in
3 place thereof the following figure:-- 5.

4 SECTION 2. Said section 13K of said chapter 265 is hereby further amended by striking
5 out, in line 73, the figure “\$1,000” and inserting in place thereof the following figure:- \$2,000.

6 SECTION 3. Said section 13K of said chapter 265 is hereby further amended by striking
7 out, in line 78, the word “five” and inserting in place thereof the following figure: - 7.

8 SECTION 4. Said section 13K of said chapter 265 is hereby further amended by striking
9 out, in line 79, the words “one thousand dollars” and inserting in place thereof the following
10 figure:- \$3,000.

11 SECTION 5. Said section 13K of said chapter 265 is hereby further amended by striking
12 out, in line 84, the word “ten” and inserting in place thereof the following figure:- 15.

13 SECTION 6. Said section 13K of said chapter 265 is hereby further amended by striking
14 out, in line 92, the word “five” and inserting in place thereof the following figure:- 7.
