An Act providing for HIV testing for at risk police officers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Notwithstanding any general or special law to the contrary, every person who receives an  
2    appointment to a position on a permanent full-time basis or on a reserve or intermittent basis in  
3    which said person will exercise police powers in a municipal police department, the  
4    Massachusetts bay transportation authority police, the department of correction, the state police,  
5    University of Massachusetts police, Massachusetts Port Authority police, the sheriffs and their  
6    employees, or the division of law enforcement within the department of fisheries, wildlife and  
7    environmental law enforcement shall, upon exposure to any known risk factor associated with  
8    HIV or AIDS as those terms are defined in Massachusetts General Laws Chapter 111, Section  
9    2D, while exercising police powers, whether in the line of duty or as a good Samaritan, be  
10   eligible for testing to determine whether such person has contracted an HIV infection or its

11 associated illnesses. Such testing shall be at the option of the exposed person and any portion of  
12 cost for three such tests undergone within eighteen months immediately following the date of  
13 exposure that is not covered under an insurance policy issued for the benefit of the exposed  
14 person shall be paid for by the Commonwealth. The exposed person shall also be eligible for  
15 psychiatric counseling in relation to such exposure. Such counseling shall be at the option of the  
16 exposed person and any portion of the cost for such counseling that is approved by the  
17 department of public health and the department of public safety that is not covered under an  
18 insured policy issued for the benefit of the exposed person shall be paid for by the  
19 Commonwealth.
