An Act relative to GIC dental and vision benefits for municipal employees.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 19 of chapter 32B of the General Laws, as appearing in the 2014  
2   Official Edition, is hereby amended by inserting after subsection (j), the following subsection:-  
  
3           (k) Notwithstanding any other general or special law to the contrary, agreements reached  
4   by an appropriate public authority and the public employee committee under subsection (a) to  
5   transfer all subscribers to the commission under subsections (e) and (f), may be modified by  
6   further agreement to allow active employees and their dependents to enroll in the dental and  
7   vision insurance plan provided by the commission to retirees, surviving spouses and their  
8   dependents under subsection (j),with premium contribution ratios and administrative fees for  
9   active employees and their dependents to be negotiated by said appropriate public authority and  
10   public employee committee. The commission shall provide dental insurance coverage, under its

11 plan for retirees, surviving spouses and their dependents insured under Chapter 32A, to active  
12 employees and their dependents who elect the coverage under this subsection, as it so provides  
13 health insurance coverage under sections (e) and (f). The commission may charge an  
14 administrative fee, which shall not be more than 1 percent of the cost of total dental insurance  
15 premiums for the active employees and their dependents who enroll in the dental plan under this  
16 section, to be determined by the commission which shall be considered as part of the cost of  
17 coverage for purposes of determining the contributions of the political subdivision and its active  
18 employees and their dependents to the cost of insurance coverage by the commission.

19 SECTION 2. Section 23 of said chapter 32B, as so appearing, is hereby amended by  
20 inserting after subsection (i), the following subsection:-

21 (j) Notwithstanding any other general or special law to the contrary, agreements reached  
22 by an appropriate public authority and the public employee committee to transfer all subscribers,  
23 for whom the authority provides health insurance coverage, to the commission under this section,  
24 may be modified by further agreement to allow active employees and their dependents to enroll  
25 in the dental and vision insurance plan provided by the commission to retirees, surviving spouses  
26 and their dependents under subsection (i), with premium contribution ratios and administrative  
27 fees for active employees and their dependents to be negotiated by said appropriate public  
28 authority and public employee committee. The commission shall provide dental insurance  
29 coverage, under its plan for retirees, surviving spouses and their dependents insured under  
30 Chapter 32A, to active employees and their dependents who elect the coverage under this  
31 subsection, as it so provides health insurance coverage under this section. The commission may  
32 charge an administrative fee, which shall not be more than 1 percent of the cost of total dental  
33 insurance premiums for the active employees and their dependents who enroll in the dental plan

34 under this section, to be determined by the commission which shall be considered as part of the  
35 cost of coverage for purposes of determining the contributions of the political subdivision and its  
36 active employees and their dependents to the cost of insurance coverage by the commission.
