An Act to deter underage drinking.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 34A of chapter 138 of the General Laws, as appearing in the 2014  
2 Official Edition, is hereby amended by inserting after the first paragraph the following  
3 paragraphs:-

4           In addition to the sanctions contained in this chapter and elsewhere, any minor, 17 to 20  
5 years and 9 months of age, who purchases, attempts to purchase or consumes alcoholic  
6 beverages, and any minor who is intoxicated in public or whose age is misrepresented to obtain  
7 alcoholic beverages shall also be punished as follows:

8           A junior operator found delinquent or guilty of any of the above shall lose the junior  
9 operator's driver's license until the junior operator attains the age of 21.

10           For a first offense finding of delinquency or guilty, the juvenile or defendant may be  
11 fined an amount up to but not exceeding \$100 and 60 days loss of license. For a second offense  
12 finding of delinquency or guilty, the juvenile or defendant may be fined not less than \$100 nor  
13 more than \$500 and 180 days loss of license. For a third offense finding of delinquency or guilty,  
14 the juvenile or defendant may be fined not less than \$100 nor more than \$1000, loss of license,  
15 and up to 1 year or the juvenile or defendant's 21st birthday in the house of correction.
