An Act relative to early college high schools.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 15A of the General Laws is hereby amended by inserting after section 39 the  
2 following section:-

3 Section 39A. (a) The commissioner of the department of higher education and  
4 commissioner of the department of elementary and secondary education shall establish and  
5 administer an early college education program to increase postsecondary completion rates and  
6 participation in career pathways. The program shall consider applications for partnerships  
7 among public secondary institutions and public and private institutions of higher education to be  
8 designated as Massachusetts Early College Schools.

9 (b) Public secondary schools receiving such designation shall provide programs open to  
10 all enrolled students, on a space available basis, and shall not discriminate on the basis of race,  
11 color, national origin, creed, sex, gender identity, ethnicity, sexual orientation, mental or physical  
12 disability, age, ancestry, special needs, proficiency in the English language or academic

13 achievement. A lottery shall be held if more students than available spots apply. There shall be  
14 no application fee or tuition charge for students participating in the program.

15 (c) The program shall allow for a minimum accumulation of 12 transferable college  
16 credits. Preference shall be given to programs offering at least one career pathway yielding an  
17 associate's degree or relevant industry credential. Academic courses offered in pathways that  
18 count for college credit may be taught by postsecondary faculty or by secondary teachers  
19 credentialed to teach postsecondary courses and shall include the transfer of any advanced  
20 placement courses taken by participating students who earn a qualifying score on the College  
21 Board advanced placement examination.

22 (d) The commissioner of the department of higher education and the department of  
23 elementary and secondary education shall establish the information required for an application  
24 for early college designation; provided that a description a high-quality early college program  
25 shall include:

26 the primary entry point grade and at least one later entry point opportunity for other  
27 students and a plan for introducing the early college program and for preparing students for the  
28 transition into the program;

29 one of more potential student academic pathways, which shall include the sequence of  
30 courses and other curricular experiences, such as internships, necessary to fulfill both secondary  
31 and post-secondary requirements;

32 the process and guidance support by which students will be exposed to sufficient  
33 information to select the pathway best suited for them and provide options to change pathways  
34 during the course of study;

35 the school's ability to partner with institutions of higher education to provide academic  
36 courses taught on postsecondary campuses, or where not logistically feasible, a plan to include  
37 postsecondary experiences;

38 the plan to offer personalized academic advising and tutoring around the pathway to  
39 postsecondary completion, which must include specific provisions to address the particular needs  
40 of limited English proficient students and students with disabilities, and may include strategies to  
41 provide non-academic supports such as guidance counseling and financial literacy; and

42 the approaches to supporting participating students' exposure to a variety of career  
43 opportunities, targeted workforce and career skills development, such as teamwork,  
44 communication, and interview preparation, and career counseling, and experiential and  
45 workplace learning, such as internships and mentorship.

46 (e) Each early college school shall enter into and maintain a memorandum of  
47 understanding with at least one institution of public or private higher education, which shall  
48 include, but not be limited to, how the program is sustainable on current funding plus anticipated  
49 annual state supplement for designated early colleges and the designated duties for each  
50 institution, in the areas of program coordination, student support, faculty support, career  
51 partnership coordination and performance monitoring.

52 (f) An early college joint committee shall be established to oversee the designation of  
53 applicants and be responsible for setting overall performance requirements and targeted  
54 enrollments for all participating programs. This joint committee shall consist of: the secretary of  
55 the executive office of education or a designee; 2 members of the board of elementary and  
56 secondary education, who shall be appointed by the chair of the board of elementary and

57 secondary education; and 2 members of the board of higher education, who shall be appointed by  
58 the chair of the board of higher education. Individual programs may negotiate further  
59 requirements with the departments.

60 (g) Designations shall be for an initial period of five years, subject to review after the first  
61 three years, and renewable subject to performance. The department of elementary and secondary  
62 education shall, subject to appropriation, provide additional funding to participating programs for  
63 each participating student.

64 (h) Annually, by July 1, early college schools shall file a report with the commissioner of  
65 the department of higher education, the commissioner of the department of elementary and  
66 secondary education and the senate and house chairs of the joint committee on higher education  
67 on performance measures, including but not limited to the following categories: (1) high school  
68 graduation rate of participating students; (2) percentage of participating students who complete  
69 the program; (3) percentage of participating students who gain any post-secondary credits; (4)  
70 percentage of participating students who gain at least 12 postsecondary credits; (5) percentage of  
71 participating students in 6-year cohort who attain an associate's degree; (6) college and career  
72 outcomes of students.

73 (i) Not later than December 31, 2017, the commissioners of the departments of  
74 elementary and secondary education and the department of higher education shall promulgate  
75 rules and regulations necessary to implement this program.
