
Dear Superintendent Rodrigues:

The Massachusetts Department of Public Health (Department) has received your Plan of Correction (POC) in response to my inspection on December 12, 13, and 14, 2017. After review, the POC does not adequately address the violations noted in the report.

1. There are instances where you state Corrected, Completed, Cleaned, Repaired, and Temperature adjusted which do not indicate compliance for the violation noted on the report. The Department requests you submit a plan indicating the specific corrective steps taken to ensure the violations are now within compliance.
2. The dates of correction provided for the violations in the Store House Male Bathroom were dated 2-18-18. Please indicate if the violation will be corrected by 2-18-18 or if the violations were corrected on a different date.
3. The dates of correction that go beyond May 2018 appear excessive; the Department would appreciate these violations corrected within a shorter time frame.
4. In regards to the issue of overcrowding, the Department appreciates the limitations of correctional facilities and the need to accommodate the ever-increasing population; however we remain concerned with the overcrowded conditions.

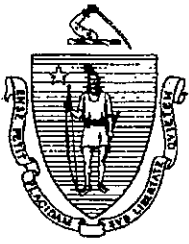

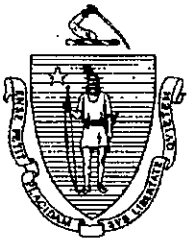
