An Act to ensure an accurate census count (2020 Vision).

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to ensure a timely and accurate census count, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. The General Laws are hereby amended by inserting after Chapter 57 the  
2 following new Chapter:-

3           Chapter 57A – Census Accuracy

4           Section 1. There is hereby established, within the office of the Secretary of State, the  
5 Massachusetts Census Equality Task Force, hereinafter called the task force.

6           (a)     The purpose of the task force shall be to ensure that Massachusetts censuses  
7 produce an accurate count of all residents of the Commonwealth, including but not limited to:

8           (1)     homeless individuals and residents of shelters

9           (2)     immigrants, both documented and undocumented who may be initially unwilling  
10 to complete the census due to fear of deportation of themselves, family, or friends

11           (3)     residents who do not speak English

12           (4)     veterans

13           (5)     individuals with disabilities

14           (b)     The task force shall be comprised of: The Secretary of State, or his or her  
15 designee, who shall serve as chair; The Attorney General, or his or her designee; The Senate  
16 Chair of the Committee on Election Laws, or his or her designee; the House Chair of the  
17 Committee on Election Laws, or his or her designee; The Senate Chair of the Committee on  
18 Redistricting, or his or her designee; the House Chair of the Committee on Redistricting, or his  
19 or her designee; The Senate Minority Leader, or his or her designee; the Minority Leader of the  
20 House of Representatives, or his or her designee; The Executive Director of the Asian American  
21 Commission, or his or her designee; a representative from Citizen Information Service (CIS); a  
22 representative from the Department of Elementary and Secondary Education; the Director of the  
23 Department of Public Safety, or his or her designee; the Director of the Department of Veterans  
24 Services (DVS), or his or her designee; The Commissioner of the Massachusetts Office of  
25 Refugees and Immigrants (ORI), or his or her designee; a representative from the Public  
26 Records Division; a representative from the Massachusetts Coalition for the Homeless; a  
27 representative from the Massachusetts Housing & Shelter Alliance, a representative from Greater  
28 Boston Legal Services (GBLS), a representative from the Massachusetts Immigrant and Refugee  
29 Advocacy Coalition (MIRA), a representative from the Refugee and Immigrant Assistance  
30 Center; a representative from the Massachusetts Alliance of YMCAs;

31           (c)     The task force shall be responsible for creating a statewide public awareness  
32 campaign to educate the general public on the importance of the census and the necessity of  
33 ensuring a complete and proper count.

34           (d)     The task force shall investigate barriers to proper counting of all residents of the  
35 Commonwealth and assess the Commonwealth's progress in preparing for upcoming censuses.  
36 Said assessment shall include but not be limited to efforts designed to accurately count all  
37 populations.

38           (e)     The chair may appoint subcommittees in order to expedite the work of the  
39 commission;

40           (f)     The task force shall meet at least monthly, for the 24 months before a census, and  
41 at least quarterly otherwise, or as frequently as the chair recommends.

42           (g)     The task force shall file an annual report, on or before January 1, with the  
43 governor, the secretary of state, the attorney general, the joint committee on election laws, and  
44 the joint committee on redistricting including any recommendations for regulatory and  
45 legislative action necessary to ensure an accurate count of all Massachusetts residents in  
46 upcoming censuses and to provide and sustain fairness in census counting. The task force shall  
47 monitor the implementation of its recommendations and update recommendations to reflect  
48 current research and statewide census needs as necessary.
