#### QUARTERLY REPORT ON MULTIPLE 51AS


This document serves as the Department of Children & Families' Quarterly Report on Multiple 51As, as required by MGL c.18B, §25, which states:

"In addition to the immediate notification required under subsection (n) of section 7, the commissioner shall report quarterly on the total number of cases of multiple 51A reports reviewed by the department under subsection (r) of section 51B of chapter 119, the types of those cases, and their resolutions. The report shall be filed with the governor, the clerks of the senate and the house, the joint committee on children, families and persons with disabilities, and the child advocate."

The Department is currently developing the capacity to track information regarding the area clinical reviews and regional clinical reviews required under MGL c.119, §51B(r). Area clinical reviews occur when three or more reports involving separate incidents have been filed on any child in a family within a 12-month period. Regional clinical reviews occur when three or more reports involving separate incidents have been filed on any child in a family within a three-month period.

In the following pages, please find the total number of multiple 51A reports reviewed by the Department under MGL c.119, §51B(r), from FY 2016, Quarter 3 through FY 2018, Quarter 3. Please note that the data presented in these graphs do not reflect whether these multiple reports were filed on the same or separate incidents.



There can be multiple 51As for one incident; therefore, some of these children only had one incident of reported abuse/neglect for which multiple 51As were filed.

March 2016: The number of children with multiple 51As within a 10-Month Period (6/1/15 through 3/31/16) was 23,075 (3.7% increase over the same time period in FY'15). Of these 23,075 children with multiple 51As: 3,027 children had 51As that were all screened-out, 2,940 children were in more than one supported investigation, and 37 children were in more than one initial assessment with a finding of concern.



There can be multiple 51As for one incident; therefore, some of these children only had one incident of reported abuse/neglect for which multiple 51As were filed.

June 2016: The number of children with multiple 51As within a 10-Month Period (9/1/15 through 6/30/16) was 24,134 (5.3% increase over the same time period in FY'15). Of these 24,134 children with multiple 51As: 2,999 children had 51As that were all screened-out, 2,992 children were in more than one supported investigation, and 12 children were in more than one initial assessment with a finding of concern.



Sep 2016: The number of children with multiple 51As within a 10-Month Period (12/1/15 through 9/30/16) was 23,015 (4.2% increase over the same time period in FY'16). Of these 23,015 children with multiple 51As: 2,916 children had 51As that were all screened-out, 2,589 children were in more than one supported investigation, and 111 were in more than one substantiated concern investigation.



Of these 22,652 children with multiple 51As: 3,110 children had 51As that were all screened-out, 2,265 children were in more than one supported investigation, and 277 were in more than one substantiated concern investigation.



Of these 21,894 children with multiple 51As: 3,244 children had 51As that were all screened-out, 1,997 children were in more than one supported investigation, and 352 were in more than one substantiated concern investigation.



Of these 23,301 children with multiple 51As: 3,440 children had 51As that were all screened-out, 1,979 children were in more than one supported investigation, and 400 were in more than one substantiated concern investigation.



Of these 22,678 children with multiple 51As: 3,461 children had 51As that were all screened-out, 1,989 children were in more than one supported investigation, and 371 were in more than one substantiated concern investigation.


