An Act providing for payment by the Commonwealth of wages for members of the United States Coast Guard during the shut-down, so-called, of the United States Government.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Notwithstanding any general or special law to the contrary the salaries of members  
2 of the United States Coast Guard who are residents of the Commonwealth shall be paid by the  
3 Commonwealth during the so-called federal government shut-down. The funds for such  
4 payments shall be paid from an account to be recommended by the Governor and determined by  
5 the committees on Ways and Means.

6           Upon the conclusion of the so-called federal government shut-down, the Commonwealth  
7 shall seek reimbursement from the federal government for the cost of all such payments made to  
8 such Coast Guard members.
