An Act to establish a Merrimack Valley River district council.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           There is hereby established Merrimack River District Council consisting of one member  
2 to be chosen from the board of selectmen or town council or the mayor, whichever is applicable  
3 or their respective designees from each of the following cities and towns: Amesbury, Andover,  
4 Billerica, Chelmsford, Dracut. Groveland, Haverhill, Lawrence, Lowell, Merrimac, Methuen.  
5 Newbury, Newburyport, North Andover, Salisbury, Tewksbury, Tyngsborough, Westford, and  
6 West Newbury who shall be voting members, and the following non-voting members: the  
7 executive directors of the Greater Lawrence, Lowell, and Haverhill Sanitary Districts or their  
8 designees and the president of the Merrimack Valley Watershed Council, MVPC. The  
9 Merrimack River District Council shall include in its review of and investigation, but not be  
10 limited to, the use of the Merrimack River, the improvement of available water resources for the  
11 district and methods for preserving, protecting, and increasing such resources; water  
12 conservation, water quality; appropriate methods to manage and develop the river and its related

13 land uses; stream flow; treatment facilities for sewage; methods for protecting water quality and  
14 quantity; fisheries and wildlife development and maintenance; recreation; cooperative efforts  
15 among cities and towns along the Massachusetts portion of the Merrimack River; cooperative  
16 efforts between the Commonwealth and the state of New Hampshire regarding the river; future  
17 water supply needs of the Commonwealth; methods for protecting the purity of the water and  
18 the costs thereof, and may make recommendations on these and other river-related issues to the  
19 department of environmental protection, the Merrimack River Legislative delegation of the  
20 General Court, and any municipality within or without the boundaries of the Council's member  
21 communities. The Council shall file report with these recommendations within fifteen months  
22 of enactment of this provision. The Council shall elect chair from among its voting members,  
23 and shall adopt such rules of procedure as necessary for the performance of its duties (consistent  
24 with the provisions of 37 Chapter 30A). The council shall receive technical assistance from the  
25 Water Resources Commission and the department of environmental protection. The council shall  
26 also be eligible to receive grants from the state or any other governmental or private entity but  
27 shall report annually to its member communities all receipts and expenditures.
