In the One Hundred and Ninety-First General Court
(2019-2020)

An Act relative to home health and hospice aides.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 80B of chapter 112 of the General Laws, as so appearing, is hereby
2 amended by inserting after the tenth paragraph the following 5 paragraphs:-

3 Registered nurses may delegate the administration of or assistance with the
4 administration of medications in the home to a home health aide, as defined under section 72F of
5 chapter 111 of the General Laws; provided, that the home health aide has completed training on
6 medication administration and meets minimum requirements according to regulations
7 promulgated by the board in conjunction with the department of public health and that the
8 administration or assistance with administration is performed under the supervision of a
9 registered nurse. Said requirements shall exempt continuous skilled nursing services pursuant to
10 130 CMR 403.410(J) and authorized pursuant to 130 CMR 403.413(C).

11 The delegation of medication administration to a home health aide permitted under this
12 section shall exclude controlled substances pursuant to Section 31 of Chapter 94c of the General
13 Laws and shall be limited to medication administration methods which are oral, ophthalmic, otic,
14 topical, internasal, transdermal, suppository, prefilled auto-injectables designed for self-
15 administration, or products which are administered by inhalation. The delegation of
16 administration methods including intramuscular, subcutaneous, intradermal that are not prefilled
17 auto-injectables designed for self-administration, intraosseous or intravenous administration of
18 medication shall not be permitted.

19 The board, in conjunction with the department of public health, shall promulgate
20 regulations pertaining to documentation protocols, minimum requirements and training on
21 medication administration. These regulations shall specify that delegation of administration of
22 medication does not alter the responsibility of the home health agency or hospice to teach and the
23 patient or family to participate in learning the self-administration of medications, whenever
24 appropriate.

25 Home health agencies shall provide training on medication administration to home health
26 aides and nurses and establish protocols on documenting that a home health aide or nurse has
27 completed training according to the nurse delegation model and the board's regulations, which
28 shall be drafted by the board in conjunction with the department of public health. Said
29 regulations shall specify that the registered nurse delegator and the home health aide are
30 accountable for their own actions in the medication delegation process, that the nurse delegator
31 shall take appropriate steps to verify the training of the home health aide, that the delegation
32 shall apply only to the home health aide to whom it was given and shall not be further delegated
33 or transferred, that no registered nurse shall be required to delegate medication administration if

34 the registered nurse determines it is inappropriate to do so and that the nurse delegator may
35 revoke the delegation based on documented professional judgment.

36 A nurse licensed under this chapter who delegates medication administration in
37 accordance with the regulations shall not be subject to disciplinary action by the board for the
38 performance of a person to whom medication administration was delegated.
