Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

| 8 | there of the words "a premium at the same rate as retirees of the governmental unit from time to |

- 9 time as part of the total cost for such hospital, surgical, medical, dental and other health
- 10 insurance".
