By Representatives Haddad of Somerset and Poirier of North Attleborough, a petition (accompanied by bill, House, No. 245) of Patricia A. Haddad, Elizabeth A. Poirier and others relative to registered interior designers. Consumer Protection and Professional Licensure.

The Commonwealth of Massachusetts

**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relative to advancing the profession of commercial interior design.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 "SECTION XX: Chapter 112 of the General Laws, as most recently appearing in the
2 2016 Official Edition, is hereby amended by inserting after section 264 the following new
3 section:

4 Section 265: Title: Registered Commercial Interior Designer

5 (A)Definitions

6 (1)“Board” means the board of registration of commercial interior designers established
7 by section one hundred and nine A of chapter thirteen.

8 (2) "Building" means an enclosed structure, including the structural, mechanical, and
9 electrical systems, utility services, and other facilities required for the structure, that has human
10 occupancy or habitation as its principal purpose and is subject to the State Building Code or an
11 approved code.

12 (3) "Certificate of registration" means the certificate of registration, issued by the board
13 every two years.

14 (4) "International Building Code" means the edition of the International Building Code,
15 issued by the International Code Council, most recently adopted by the state in the eighth edition
16 of the State Building Code.

17 (5)(a) "Practice of commercial interior design" means, in relation to obtaining a building
18 permit independent of an architect licensed under sections 60A through 60O of chapter 112 of
19 the general laws, the preparation of a plan or specification for, or the supervision of new
20 construction, alteration, or repair of, an interior space within a newly constructed or existing
21 building when the core and shell structural elements are not going to be changed.

22 (b) "Practice of commercial interior design" only includes the preparation of a plan or
23 specification for, or the supervision of new construction, alteration, or repair of, a building.

24 (c) "Practice of commercial interior design" does not include: (i) providing commercial
25 construction documents, independent of a licensed architect, for a space that: (ii) does not
26 already have base building life safety components installed or designed and permitted, including
27 required exit stairs and enclosures, paths of travel, ramps, horizontal exit passageways, disabled
28 access, fire alarm systems, and base building fire suppression systems; or (iii) is undergoing a
29 change of occupancy classification as described in the International Building Code; or changes
30 to or the addition of foundations, beams, trusses, columns, or other primary structural framing
31 members or seismic systems; structural concrete slabs, floor and roof framing structures, or
32 bearing and shear walls; openings in roofs, floors, exterior walls, or bearing and shear walls;
33 exterior doors, windows, awnings, canopies, sunshades, signage, or similar exterior building

34 elements; as described in the International Building Code, life safety equipment, including
35 smoke, fire, or carbon dioxide sensors or detectors, or other overhead building elements; as
36 described in the International Building Code, bracing for partial height partitions if the top of the
37 partition is more than eight feet above the floor; or heating, ventilating, or air conditioning
38 equipment or distribution systems, building management systems, high or medium voltage
39 electrical distribution systems, standby or emergency power systems or distribution systems,
40 plumbing or plumbing distribution systems, fire alarm systems, fire sprinklers systems, security
41 or monitoring systems, or related building systems.

42 (6) "State registration" means a designation granted by the administration on behalf of the
43 state to an individual who has met the requirements for state registration related to an occupation
44 or profession described in this chapter.

45 (7) "State registered" means, when used in conjunction with an occupation or profession
46 described in this chapter, a title that:

47 (a) may be used by a person who has met the state registration requirements related to
48 that occupation or profession described in this chapter; and

49 (b) may not be used by a person who has not met the state registration requirements
50 related to that occupation or profession described in this chapter.

51 (B) Testing Requirement

52 Any individual who has passed the interior design examination administered by the
53 National Council for Interior Design Qualification (NCIDQ) may use the title "Registered
54 Commercial Interior Designer." Such individual shall, upon satisfactory completion of the

55 aforementioned requirements, send to the office of director of professional licensure a copy of
56 documentation of the proof of passage of said exam, of graduation and completion of said
57 program, and any certifications awarded to said individual by the National Council for Interior
58 Design Qualification, with said individual's name, present mailing address and email address,
59 and any changes there to as such changes occur. Such documentation shall be placed on file in
60 the office of said director.

61 (C) Application; Renewal; Re-Activation

62 Each applicant seeking to become a registered commercial interior designer shall pay to
63 the board, upon filing his or her original application a fee to be determined annually by the
64 commissioner of administration. After verification of the aforementioned documentation and
65 receipt of the application fee, the board shall issue a certificate of registration for a period of two
66 years. The director of the division of professional licensure, or his designee, as the custodian of
67 any documentation required by this section shall enforce the provisions of said section and may
68 use said documentation, or any lack thereof, as he, or his designee, deems necessary,
69 notwithstanding any General or special Law, or rule or regulation to the contrary.

70 A Registered Commercial Interior Designer shall be required to continue learning and
71 stay abreast of current knowledge in the profession by completing continuing education units
72 (CEUs). Continuing education shall be gained through coursework delivered in education units.
73 The quantity and content designation of education units (CEUs) shall be determined by the
74 division of professional licensure.

75 It shall be unlawful for any individual, who is not so qualified by reason of having passed
76 such examination, or who does not have such experience to use the title "Registered Commercial

77 Interior Designer” or any title or device indicating that an individual is a “registered commercial
78 interior designer.”

79 Nothing herein shall prohibit any person from performing commercial interior design
80 services or using the title “commercial interior designer,” “commercial interiors consultant,”
81 “commercial interior decorator” or the like, so long as the word “registered” is not used in
82 conjunction with the word “commercial interior designer.”

83 Nothing herein shall authorize any individual to engage in the practice of architecture,
84 engineering, or any other occupation regulated under the laws of this state or to prepare, sign or
85 seal plans with respect to such practice or in connection with any governmental permits unless
86 licensed or otherwise permitted to do so under such laws.

87 Nothing in this section shall prohibit an employee of a retail establishment providing
88 consultation regarding interior design, decoration, furnishings, furniture or fixtures offered for
89 sale by such establishment from receiving compensation from such establishment.

90 Notwithstanding any general or special law to the contrary, an individual who has
91 completed at least 10 years of full-time, diversified, verifiable professional experience in the
92 profession of interior design shall be eligible for “provisional registration” provided that within
93 twelve months after the first meeting of the board, said individual has applied for registration.

94 Said applicant, upon review and consent of the board, may be issued a “provisional
95 registration” and be given three calendar years from the first meeting of the board to provide
96 substantial proof to the board of successful passage of the NCIDQ examination, at which time
97 full registration will be granted. If proof is not provided to the board within the allotted time
98 period, said applicant’s “provisional registration” shall be revoked and become null and void.

99 Re-application, including satisfaction of all requirements at the time of re-application, shall be
100 required for registration. During the time period of “provisional registration,” said individual is
101 required to maintain all current fees and uphold all requirements registration and renewal until
102 such time as the examination requirement is fulfilled.

103 Any individual violating the provisions of this section shall be punished via a fine and/or
104 one’s registration revoked by the division of professional licensure.

105 (D) Seal of registered commercial interior designer

106 Every registered commercial interior designer shall have a seal of a design authorized by
107 the board. All plans and specifications and reports prepared by a registered commercial interior
108 designer or under his supervision shall be stamped with the impression of such seal. A registered
109 commercial interior designer shall impress her or her seal on any plans or specifications on if his
110 certificate of registration is in full force and if he or she was the author of such plans and
111 specifications or in responsible charge of their preparation.

112 (E) Roster of registered commercial interior designers

113 A roster, showing the names and the last known places of business of all registered
114 commercial interior designers, shall be prepared by the board in the month of January of each
115 year. Such roster shall be posted on a publicly available website.

116 (F) Certificate of registration as a commercial interior designer emeritus

117 (a) Upon receipt of a written application, the board may grant a certificate of registration
118 as a commercial interior designer emeritus to an interior designer who has retired from the active
119 practice of commercial interior design in the commonwealth. To be eligible for a certificate of

120 registration as a commercial interior designer emeritus, the applicant shall: (i) submit an
121 application together with a fee prescribed by the board; (ii) have been a commercial interior
122 designer in good standing in the commonwealth at the time of his retirement; (iii) be at least 65
123 years of age; (iv) have been a registered a commercial interior designer in the commonwealth for
124 at least 10 years; (v) have relinquished his license to practice commercial interior design; and
125 (vi) satisfy any other requirements as may be prescribed by the board.

126 (b) A commercial interior designer emeritus shall not engage in nor hold himself out as
127 engaging in the practice of commercial interior design. A commercial interior designer emeritus
128 shall be exempt from the continuing education requirements established in this chapter.

129 (c) A commercial interior designer emeritus seeking reinstatement as a commercial
130 interior designer shall: (i) file an application for reinstatement with the board; (ii) pay an
131 administrative fee which shall be determined by the board; and (iii) comply with education or
132 other requirements established by the board.

133 (G) Enforcement by board; attorney general; duties

134 The board shall be charged with the enforcement of sections 265A to 265F, inclusive. If
135 any person refuses to obey any decision of the board, the attorney general shall, upon request of
136 the board, file a petition for the enforcement of such decision in equity in the superior court for
137 Suffolk county or for the county in which the defendant resides or has a place of business. After
138 due hearing, the court shall order the enforcement of such decision or any part thereof, if legally
139 and properly made by the board.

140 SECTION XX: Chapter 13 of the General Laws, as most recently appearing in the 2014
141 Official edition, is hereby amended by inserting after Section 108 the following new sections:

142 Section 109A: Title: Board of registration of commercial interior designers; membership;
143 appointment; term

144 There shall be in the department of civil service and registration a board of registration of
145 commercial interior designers, in this and the following three sections called the board, to be
146 appointed by the governor, consisting of five members, citizens of the commonwealth, four of
147 whom shall each have been engaged in the practice of interior design for a period of ten years or
148 more prior to his appointment, and shall be registered commercial interior designers. The fifth
149 member shall be a representative of the public, subject to the provisions of section nine B. As the
150 term of office of a member of the board expires, his successor, qualified as aforesaid, shall be
151 appointed by the governor, to serve for five years. Each member shall continue to serve until the
152 qualification of his successor. The governor may also fill any vacancy in the board for the
153 unexpired portion of the term.

154 Section 109B: Board of registration of commercial interior designers; meetings; officers;
155 quorum

156 The board shall hold at least two regular meetings each year, and may hold special
157 meetings as required. Time, place and notice of all meetings shall be as required by rules or by-
158 laws determined by the board. At the first regular meeting each year, the board shall organize
159 and choose from its own members, a chairman, a vice chairman and a secretary. A quorum shall
160 consist of three members.

161 Section 109C: Board of registration of commercial interior designers; rules and by-laws;
162 seal; powers; annual report

163 The board may make such rules or by-laws, not inconsistent with law, as it may deem
164 necessary in the performance of its duties. The board shall have a seal, and its members may
165 administer oaths in the performance of its duties. The board shall have power to summon
166 witnesses and to take testimony and require proofs concerning all matters within its jurisdiction.
167 The board shall annually render to the governor a report of its proceedings, which shall include
168 an itemized statement of all receipts and expenses of the board for the year.

169 Section 109D: Board of registration of commercial interior designers; compensation and
170 reimbursement of expenses

171 The members of the board shall serve without compensation but shall be reimbursed for
172 actual and necessary expenses reasonably incurred in the performances of their duties as
173 members or on behalf of the board."
