- 6 the 2016 Official Edition, is hereby amended by inserting after the word "activities," in line 25,
- 7 the following words:- "with a particular focus on progress toward achieving compliance with the
- 8 Global Warming Solutions Act, and reaching one-hundred percent renewable energy,"
