An Act protecting ratepayers from gas pipeline expansion costs.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 94A of chapter 164 of the General Laws is hereby amended by adding, at the end  
2 the existing section, the following text:

3 Notwithstanding anything set forth herein, the department shall not approve any contract  
4 for the purchase of gas, gas pipeline capacity or liquefied gas storage where any contract costs  
5 would be recoverable from the ratepayers, if such contract requires any construction or  
6 expansion of interstate gas infrastructure.
