The Commonwealth of Alassachusetts

In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to the continued enhancement of the offshore wind industry in the Commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Subsection b of section 83C of chapter 169 of the Acts of 2008, as amended
- 2 by chapter 188 of the acts of 2016, is hereby amended by striking out the figure "1600" and
- 3 inserting in place thereof the following figure:- 3,200
- 4 SECTION 2. Said subsection b in section 83C is hereby further amended by striking out
- 5 the figure "24" and inserting in place thereof the following figure:- 12
- 6 SECTION 3. Said subsection b in section 83C is hereby further amended by striking out
- 7 the following:-
- 8 "; provided, however, that the department of public utilities shall not approve a long-term
- 9 contract that results from a subsequent solicitation and procurement period if the levelized price
- per megawatt hour, plus associated transmission costs, is greater than or equal to the levelized
- price per megawatt hour plus transmission costs that resulted from the previous procurement"

SECTION 4. Said section 83C is hereby further amended by inserting after subsection d the following new subsection:-

(e) The winning bid shall be chosen by the selection committee which shall consider all proposals and criteria in subsection (d) when making a final decision. The committee shall consist of the following members: the secretary of energy and environmental affairs, which shall be the chair; the attorney general; the secretary of the executive office of housing and economic development; and the house and senate chairs of the joint committee on telecommunications, utilities and energy.
