By Representative McKenna of Webster and Senator Fattman, a joint petition (accompanied by bill, House, No. 291) of Joseph D. McKenna and Ryan C. Fattman (by vote of the town) that the town of Webster be authorized to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises. Consumer Protection and Professional Licensure. [Local Approval Received.]

The Commonwealth of Massachusetts

An Act authorizing the town of Webster to grant an additional license for the sale of all alcoholic beverages to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding Sections 17 of Chapter 138 of the General Laws, or any
2 other general or special law to the contrary, the Licensing Authority of the Town of Webster may
3 grant a license for the sale of all alcoholic beverages to be drunk on the premises under Section
4 12 of said Chapter 138 to Waterfront Mary's, LLC, at 103 Birch Island Road in Webster, MA.
5 The license shall be subject to all of said Chapter 138, except said Section 17. The Licensing
6 Authority shall not approve the transfer of the license to any other person, organization,
7 corporation, or location but it may grant the license to a new applicant at the same location if the
8 applicant files a letter from the Department of Revenue indicating that the licensee is in good
9 standing with the Department and all applicable taxes have been paid. Upon the issuance of the
10 license authorized in this act, Waterfront Mary's, LLC, shall return to the Licensing Authority

11 the license it currently holds for the seasonal sale of all alcoholic beverages to be drunk on the
12 premises.

13 If the license granted under this act is cancelled, revoked, or no longer in use, it shall be
14 returned physically with all of the legal rights, privileges and restrictions pertaining thereto to
15 the Licensing Authority and the Licensing Authority may then grant the license to a new
16 applicant at the same location under the same terms and conditions as specified in this act.

17 SECTION 2. This act shall take effect upon its passage.
