**In the One Hundred and Ninety-First General Court  
(2019-2020)**

An Act providing for the board of library commissioners.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. To provide for a program of capital facility repairs and improvements to  
2 protect and improve the capital facilities of the commonwealth and for a program of capital asset  
3 acquisitions for general government operations, the sums set forth in sections 2, 2A, 2B and 2C,  
4 inclusive, for the several purposes and subject to the conditions specified in this act are hereby  
5 made available, subject to the laws regulating the disbursement of public funds, which sums shall  
6 be in addition to any other amounts previously appropriated for these purposes; provided,  
7 however, that the amounts specified for a particular project may be adjusted in order to facilitate  
8 projects authorized in this act.

9           SECTION 2.

10           Board of Library Commissioners.

11           7000-9091 For a program of grants to cities and towns for approved public library  
12 projects pursuant to sections 19G to 19J, inclusive, of chapter 78 of the General Laws; provided,

13 that \$500,000 shall be expended by the board of library commissioners for the administrative  
14 costs directly attributable to the projects funded in this item, including the costs of temporary  
15 personnel; provided further, that no permanent personnel shall be compensated from this item;  
16 provided further, that the board shall file an annual spending plan with the executive office for  
17 administration and finance and the house and senate committees on ways and means which  
18 details, by subsidiary, all temporary personnel and administrative costs charged to this  
19 item.....\$151,200,000

20 SECTION 3. To meet the expenditures necessary in carrying out section 2, the state  
21 treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an  
22 amount to be specified by the governor from, time to time, but not exceeding, in the aggregate,  
23 \$151,200,000. All such bonds issued by the commonwealth shall be designated on their face,  
24 Capital Improvement Act of 2018, and shall be issued for a maximum term of years, not  
25 exceeding 30 years, as the governor may recommend to the general court pursuant to section 3 of  
26 Article LXII of the Amendments to the Constitution. The bonds shall be payable not later than  
27 June 30, 2052. All interest and payments on account of principal on these obligations shall be  
28 payable from the General Fund. Bonds and interest thereon issued pursuant to this section shall,  
29 notwithstanding any other provision of this act, be general obligations of the commonwealth.
