An Act relative to the Lafayette Trail.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 2. Chapter 29 of the acts of 1997 is hereby amended by inserting after the first  
2 paragraph the following paragraph:-

3 The following portions of state highway shall be designated and known as the General  
4 Lafayette Trail: that portion of Massachusetts Route 9 beginning in the town of Belchertown and  
5 continuing easterly

6 until the intersection with Massachusetts Route 32 in the town of Ware; that portion of  
7 Massachusetts Route 32 beginning in the town of Ware and continuing easterly until the  
8 intersection with Massachusetts Route 9 (East Street); that portion of Massachusetts Route 9  
9 beginning in the town of Ware and continuing easterly until the intersection with Stafford Street  
10 in the town of Worcester; that portion of Massachusetts Route 20 beginning in the town of  
11 Fiskdale at the intersection with Holland Road and continuing easterly until the intersection with  
12 Massachusetts Route 131 in the town of Sturbridge; that portion of Massachusetts Route 20

13 beginning in the town of Sturbridge at the intersection with Hall Road and continuing easterly  
14 until the intersection with Stafford Street; that portion of Stafford Street beginning in the town of  
15 Sturbridge at the intersection with Massachusetts Route 20 and continuing northeasterly until the  
16 intersection with Main Street in the town of Worcester;. The department of highways shall erect  
17 and maintain suitable markers bearing said designations.
