### The Commonwealth of Alassachusetts

In the One Hundred and Ninety-First General Court (2019-2020)

An Act to expand veteran license plate eligibility.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Clause 43 of section 7 of chapter 4 of the General Laws, as appearing in
- 2 the 2016 Official Edition, is hereby amended by inserting after the words "active service." in line
- 3 336 the following:—
- Any person who is entitled, under chapter 1223 of title 10, United States Code, as
- 5 amended from time to time, to retired pay for nonregular service or, but for age, would be
- 6 entitled under such chapter to retired pay for nonregular service, shall be honored as a veteran for
- 7 purposes of qualification for distinctive registration plates under section 2 of chapter 90 but shall
- 8 not be entitled to any other benefit by reason of this honor.
