**In the One Hundred and Ninety-First General Court  
(2019-2020)**

An Act relative to Registry of Motor Vehicles.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 90 of the General Laws is hereby amended by adding the following  
2 section:-

3 Section 63. There shall be a third-party audit of the database of the registry of motor  
4 vehicles for the purpose of detecting and identifying: (i) existing license holders for potential  
5 fraud or duplicate issuances of license/registrations; (ii) anomalies in licensed identities; (iii)  
6 potential fraud rings; (iv) addresses containing post offices boxes; and (v) other such anomalies  
7 and fraud indicators. For the purposes of this section the term “third party audit” shall mean an  
8 independent review and examination of registry of motor vehicles data pursuant to clauses (i) to  
9 (v), inclusive.

10 SECTION 2. Notwithstanding any general or special law or rule or regulation to the  
11 contrary, the first audit required by this act shall take place on or before December 1, 2019.

12           SECTION 3. The registrar of motor vehicles shall promulgate emergency regulations to  
13   implement this act no later than 30 days after the passage of this act.
