The Commonwealth of Massachusetts

In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to protecting residential electric customers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Chapter 164 of the General Laws is hereby amended by inserting after
section 1K the following section:

3 Section 1L. Beginning on January 1, 2020, no supplier, energy marketer, or energy 4 broker shall execute a new contract for generation services with any individual residential retail 5 customer. This provision shall not apply to, or otherwise affect, any government body that 6 aggregates the load of residential retail customers as part of a municipal aggregation plan 7 pursuant to chapter 164, § 134. Any violation of this provision shall be deemed an unfair and 8 deceptive act pursuant to the provisions of chapter 93A, and the attorney general is hereby 9 authorized to bring an action under section 4 of chapter 93A to enforce this provision and to 10 obtain restitution, civil penalties, injunctive relief, and any other relief awarded pursuant to said 11 chapter 93A.
