Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 15 of chapter 19A of the General Laws, as appearing in the 2016
- 2 Official Edition, is hereby amended in line 6 by inserting after the words "outreach worker
- 3 employed by a council on aging," the following:- "veterans' service officers,"
- 4 SECTION 2. Section 1 of Chapter 19C of the General Laws, as so appearing, is hereby
- 5 amended in line 28 by inserting after the words "foster parent," the following:- "veterans' service
- 6 officers,"
