An Act relative to parking at certain airports for disabled veterans.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 5 of chapter 465 of the acts of 1956 is hereby amended by adding the following  
2 paragraph:-

3           No fee shall be exacted and no penalty shall be imposed by the Authority for the parking  
4 of any vehicle owned and driven by a disabled veteran bearing the distinctive number plates  
5 authorized by section 2 of chapter 90 at an airport property.
