**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-First General Court  
(2019-2020)**

An Act for providing for the training, continuing training, and education of judges, and other legal hearing officers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The Massachusetts General Laws are hereby amended by inserting the  
2 following new chapter:

3 An Act to provide for the training, continuing training, and education of judges, and other  
4 legal hearing officers.

5 1.) Massachusetts, as a leader in legal reform, and legal systems, has accomplished many  
6 important reforms, and contributed to the general structures, and processes of law. This  
7 includes,

8 of course, case study law itself, many consumer protections, and many other innovations.

9 2.) Therefore, this Statute, establishes, and encourages, a robust formal framework, for

10 the training of all judges, and other legal hearing officers. In a rapidly changing society,  
11 everyone, including legal officials, are especially challenged by changes in technology,  
12 social  
13 viewpoints, societal consensus, business operations and circumstances, and legal  
14 doctrines and  
15 operations.

16 3.) The Attorney General of Massachusetts, in consultation with the Board of Bar  
17 Overseers, and other appropriate individuals, and organizations, is empowered, to  
18 establish

19 Judicial Training: defined as suitable judicial training, judicial continuing education,  
20 training and

21 education for all legal hearing officers of the Commonwealth, including Magistrates,  
22 Hearing

23 Officers, and those individuals who are members of Boards and Commissions, which  
24 make  
25 regulatory, and legally-binding decisions.

26 4.) All individuals, meeting the requirements of this Act, shall receive specified initial  
27 training, at the beginning of their appointments, and regular update training, on a yearly  
28 basis, as

29 specified in such needed regulations, as the Attorney General, shall create, and monitor,  
30 in  
31 conjunction with the relevant supervising justices, of each appropriately defined judicial  
32 system.
