An Act clarifying business permitting procedures.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 MGL Chapter 94G Sec 3(b) shall be amended by adding at the end:

2 “No local voter initiative shall be required if the sale of marijuana and marijuana products  
3 for consumption on the premises is authorized by local law.”

4 MGL Chapter 94G Section 13(c) shall be amended by replacing the words “has voted to  
5 allow consumption on the premises where sold” to “does not forbid consumption on the premises  
6 where sold.”

7 MGL Ch 270, Section 22, shall be amended by

8 (1) adding the following definition to subsection (a):

9 “Licensed marijuana social consumption establishment”, a facility or venue approved by  
10 the Cannabis Control Commission for sale of marijuana for consumption on the premises

11 (2) adding to subsection (c), a new subsection 5 ½:

“A licensed marijuana social consumption establishment.”
