An Act establishing a commission to review health insurance coverage for medically necessary treatment in public schools.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. A special commission, to consist of: 2 members of the senate, 2 members of  
2 the house of representatives, the secretary of elementary and secondary education, the  
3 commissioner of the department of public health, the director of MassHealth and 3 persons to be  
4 appointed by the governor, 1 of whom shall be appointed from a list provided by Massachusetts  
5 Advocates for Children; 1 of whom shall be appointed from a list provided by the Boson Medical  
6 Center; and 1 of whom shall be the president of the Massachusetts School-Based Health  
7 Alliance, is hereby established pursuant to section 2A of chapter 4 for the purpose of making an  
8 investigation and study relative to health insurance coverage for medically necessary treatment in  
9 public schools.

10           SECTION 2. The commission shall report to the general court the results of its  
11 investigation and study and its recommendations, if any, together with drafts of legislation

- 12 necessary to carry its recommendations into effect, by filing the same with the clerk of the senate
- 13 and the clerk of the house of representatives on or before December 31, 2019.
