By Mr. Straus of Mattapoisett, a petition (accompanied by bill, House, No. 4009) of William M. Straus (by vote of the town) that the town of Fairhaven be authorized to transfer an interest in certain park land. Municipalities and Regional Government. [Local Approval Received.]

An Act authorizing the town of Fairhaven to transfer an interest in certain park land.

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to authorize forthwith the conveyance of an interest in certain land in the town of Fairhaven, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding any general or special law to the contrary, the board of
2 selectmen of the town of Fairhaven may grant a parking, access and utility easement, or any
3 lesser interest, in that portion of Livesey Park bounded and described as follows: commencing at
4 a point on the easterly sideline of Livesey Parkway, and the southerly sideline of Morton Street,
5 thence turning and running; S12°56'05"E, ten and no hundredths (10.00) feet along the sideline
6 of said Livesey Parkway, to the Point of Beginning; thence turning and running N76°16'33"E,
7 sixty nine and seventy hundredths (69.70) feet to a point, thence turning and running:

8 N12°03'14"W, fourteen and twenty nine hundredths (14.29) feet to a point, thence
9 turning and running:

10 N64°31'53"E, twenty six and forty one hundredths (26.41) feet to a point, thence turning
11 and running:

12 S14°36'26"E, two hundred eighty four and four hundredths (284.04) feet to a point,
13 thence turning and running:

14 S76°07'22"W, one hundred four and no hundredths (104.00) feet to a point on the
15 easterly sideline of Livesey Street, thence turning and running along the sideline of said Livesey
16 Street:

17 N12°56'05"W, two hundred sixty four and sixty five hundredths (264.65) feet to the Point
18 of Beginning.

19 The above described parcel contains an area of twenty six thousand nine hundred thirty
20 (26,930) square feet or 0.618 +/- acres.

21 SECTION 2. This act shall take effect upon its passage.
